**AMENDED INVITATION TO SUBMIT EXPRESSION OF INTEREST AND  
TO APPLY FOR ELIGIBILITY AND TO BID**

**CONTRACT OF SERVICES FOR THE OPERATION AND MAINTENANCE OF  
LIGHT RAIL TRANSIT AUTHORITY (LRT) LINE 1 AND METRO RAIL TRANSIT (MRT)  
LINE 3 SYSTEMS**

1. The Department of Transportation and Communications (DOTC) invites interested firms and entities for the bidding of a four (4) year period, extendable by one (1) year, contract of services, functions, facilities, and associated resources for the Operation and Maintenance of the Light Rail Transit (LRT) Line 1 and the Metro Rail Transit (MRT) Line 3 Systems. Funding for the subject contract shall be provided by the Government of Philippines (GOP). The Approved Budget for the Contract is Fourteen Billion (Php14,000,000,000.00) Pesos for purposes of determining the qualifications of bidders, among others.
2. Prospective bidders should have completed a similar single contract with a value of at least 50% of the Approved Budget for the Contract (ABC) and should meet all other minimum eligibility requirements stated in the Eligibility Documents.
3. The procurement of the required services shall be conducted through open competitive bidding procedures provided for by Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act" and its Implementing Rules and Regulations.
4. Any firm or entity interested in the project must submit formal expression of interest not later than 15 April 2011 accompanied by payment of a non-refundable fee of TEN THOUSAND (Php10,000.00) PESOS through the address given below. Interested parties may likewise obtain further information from the said given address and telephone number or thru e-mail address [rsr@dotc.gov.ph](mailto:rsr@dotc.gov.ph).
5. Eligibility Documents and Tender Documents shall only be issued to firms and entities which have duly submitted their respective formal expressions of interest and paid the required fee on time.
6. Tender Documents shall likewise be issued only upon payment of appropriate non-refundable Tender Documents fee.
7. Pre-eligibility and Pre-bid Conferences shall be conducted to provide proper guidance to bidders in the preparation of their Eligibility and Tender documents.
8. The schedule of the above-mentioned conferences and submission of Eligibility Applications and Tender Documents including other dates and basic data pertinent to the procurement proceedings shall be duly provided later to those which have submitted formal expressions of interests.
9. DOTC reserves the right to accept or reject any or all bid(s), to annul the bidding process and to reject all Eligibility Documents or Bids, without thereby incurring any liability to the affected Bidder or Bidders.
