PROJECT : GLOBAL HEALTHCARE INSURANCE COVERAGE

This Addendum No. 4 is issued to furnish the bidders with amendments on the **Membership Eligibility** for the GLOBAL HEALTHCARE INSURANCE COVERAGE as stated in the **Terms of Reference** which shall be read as follows:

The following persons shall be eligible for health care coverage:

- a. All permanent employees of the Department of Foreign Affairs and its attached agencies who are posted abroad.
- b. Dependents of the above mentioned employees, namely:
 1. The lawful spouse
 2. Children (legitimate, illegitimate, or adopted) and stepchildren of the principal.
This covers:
Children from birth up to at least 21 years of age;
Children over 21 years of age provided they are mentally, physically, or developmentally incapacitated and are primarily dependent on the principal for support;
Children from 21 to 26 years of age provided they are attending an accredited institution of higher learning on full time basis and are primarily dependent on the principal for support.
 3. **Dependent parent/s of single and married personnel without children.**
- c. **Principal Members shall have the option of enrolling on their sole and full account their private staff. The same optional arrangement shall be available to parents of married personnel with dependent children.**

In addition to the Financial Bid Form (Annex "E" of the Instruction to Bidders), **Annex "E-1"**, herein attached, shall likewise be accomplished and submitted on the Opening of Bids as part of the bidder's FINANCIAL DOCUMENT.

Bidders are likewise reminded that the **deadline for Submission of Bid Documents** is rescheduled on **24 January 2012, 2:00 p.m.**, at the BAC Secretariat, 3rd Floor, DFA Main Building, Roxas Boulevard, Pasay City. **Opening of Bids** for the Project will also be on **24 January 2012, 2:30 p.m.** at the OLA Conference Room, 3rd Floor, DFA Main Building, Roxas Boulevard, Pasay City..
